4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

Inhalation Due to product form / nature of use, an inhalation hazard is not anticipated.

Skin If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.

Evacuate area and contact emergency services. Toxic gases may be evolved in a fire situation. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.

Additional information

WORK PRACTICES - SOLVENTS: Organic solvents may present both a health and flammability hazard.
